Note

- Committals are remand prisoners on capital charges who have been committed for trial by the high court. They are not eligible for bail.
- Lodgers are persons detained in prison without a court order.

Answers

(a) (i) Determine the actual number of inmates per prison.


The actual number of inmates per prison

Murchison bay	484 + 1,129	= 1613	
Luzira upper	211 + 69 + 1776	= 2056	
Arua	192 + 361	= 553	
Rukungiri	47 + 203	= 250	
Kumi	19 + 58	= 77	
Jinja main	249+338 + 33	= 620

(ii) Draw a group (comparative) bar graph to represent the planned and actual number of inmates for prisons shows in the table



Vertical scale: 1cm repesents 500 inmates

- (b) (i) Identify the prison with the largest number of inmates Luzira Upper
 - (ii) Account for the largest number of inmates identified in b(i) above
 - It is the main /national prison
 - It is located in the capital city with the highest population density
 - Slow judicial process
 - It near the Uganda Supreme court, court of appeal, General court martial
 - Has the highest form of security to hold hard core criminals
 - Some prisoners fail to pay for bail or to raise
- (c) What are the consequences of exceeding the planned capacity of prisons?
 - Overcrowding leading to poor sanitation
 - Easy spread of diseases
 - Under feeding/poor feeding
 - Danger of mixing hard core criminals and petty criminals
 - Vices develop e.g. torture, vulgar language. homosexuality
 - Violation of prisoners' rights
